

## **Marston Steam & Vintage Show 22<sup>nd</sup> 23<sup>rd</sup> August 2026**

### **Public Camping Terms & Conditions**

#### **Arrival and Departure**

No arrivals before 12 Noon on Friday 21<sup>st</sup> August 2026

No arrivals after 21:00 on Friday 15<sup>th</sup> August 2025, unless by prior arrangement.

All Caravans, Motorhomes, Campervans and Tents **MUST** vacate the site by 12:00 on Monday 24<sup>th</sup> August 2026.

#### **Site and Site Staff**

The show site is farmland which is grassed and can be uneven and slippery. Please take care and ensure you wear suitable footwear for this type of surface. Marston Steam and Vintage Show take no responsibility for any injuries caused from trips or falls due to uneven ground.

The campsite and show field are manned 24hrs by Security. In case of emergency, security can be contacted via a number provided in your welcome pack when you arrive to site.

Staff and Security have the right to refuse entry to or expel anyone who behaves in an anti-social manner or damages property.

#### **Pitches**

Pitches for Pre-Bookings will be pre-allocated at the time of acceptance of booking.

All pitches will be 8m x 7m. It is your responsibility to ensure that you can fit your vehicle and Unit on the pitch allocated to you. If you decide to bring extras (awnings, pop-up tents, gazebos etc.), then these must also fit within the boundaries of the allocated pitch.

Park caravans as instructed (see diagram). In accordance with Fire and Rescue guidelines, all tents and caravans require at least a 6-metre fire break space and/or aisle space. If you pitch outside the boundaries of your pitch, or your Unit is judged to pose a risk to the safety and comfort of others, you may be asked to move.


The Rally site is farmland which is grassed and can be uneven, and pitches are unlikely to be totally level. Please ensure you have sufficient blocks / ramps / chocks available to level your unit.

Tents should have their cooking area as close to the centreline of the pitch as possible. There must be a 6m. gap between adjacent accommodation (caravan, motorhome, campervan, tents).

Awnings are allowed. For safety reasons awnings must not face each other. Vehicles may be parked between accommodation but must be within your allocated pitch.

N.B. If a second vehicle is required, because of the total number of adults and children or because of different arrival times of the occupants, this is allowed at no extra cost provided both vehicles can be accommodated within the pitch length.

Please specify both registration numbers on the Booking Form along with the number of adults and children arriving in each vehicle to allow passes to be produced for both vehicles.



### **Safety, Security and Comfort**

There is a 5m.p.h. speed restriction on site, which **MUST** be always adhered to. The exceptions will be given to emergency services, security and occasionally show service vehicles.

All drivers must hold a full driving licence for the type of vehicle being driven on site. The use of Motorised trikes and quadbikes is **NOT** allowed on site, any person found to be using any of these types of vehicles will be asked to leave the site.

Gates to the site will be locked between 23:00 and 07:00. No Vehicle movement is allowed on site between 23:00 and 07:00.

Noise should be kept to a minimum between 23:00 and 07:00. Generators may be used, at the discretion of the site stewards, between 09:00 and 21:00.

Please ensure that fuel is stored in approved and marked containers, that exhausts do not annoy adjoining pitches, and that all necessary safety precautions are taken with connections.

The use of drones is **NOT** allowed on the Public Caravan and Camping site, Show fields, Exhibitor Camping fields, or Car Park at any time, except with the written permission of the organisers.

### **Payments and passes**

Payment for Pre-Bookings **MUST** be made at the time of booking, to guarantee pitches. We do not accept payment on arrival for pitches.

Once payment for your pitch has been successful, we will send out passes for your vehicle and/or caravan/Motorhome along with wristbands for all paying occupants. Please make sure the passes are always clearly visible on your vehicles during the show.

Please always wear the wristbands, these will allow you to gain access to the main show ground from the campsite.

### **Visitors**

If you have visitors meeting you over your stay, they will be asked to park in the public carpark, to minimise vehicle movement on site. For those with mobility issues a limited amount of parking will be available near the entrance to the Show fields.

Visitors who have not paid for camping will be charged the daily entrance fee on the pay gate (£10.00 per adult per day or £15 for the weekend, accompanied children FREE).

### **Water, Sanitation and Rubbish**

Fresh drinking water will be available from several locations around the site. Please ensure taps are fully turned off after use.

**Taps designated for drinking water only and MUST NOT be used for any other purpose, i.e. washing hands or cleaning chemical toilets.**

Chemical toilets **MUST** only be emptied in the chemical disposal tanks which will be located around the site.

Please use the bins around the camp site to dispose of general rubbish, these will be emptied regularly over the weekend.

Toilet facilities will be available in the campsite from the afternoon of Friday 21<sup>st</sup> August until 10:00 on Monday 24<sup>th</sup> August.

Please do **NOT** use toilets for emptying chemical waste or grey water and use the designated IBC.

### **Barbeques and Campfires**

Only gas barbeques are allowed in the camping area, strictly **NO** Charcoal barbeques. All cooking appliances must be fitted on an adequate stand and not placed directly on the grass.

Please ensure that the ground does not get damaged.

Campfires are **NOT** permitted under any circumstances.

### **Pets**

Pets are welcome on site, but you are responsible for the behaviour of your animals. Please ensure that your animals are not allowed loose on site and are always kept on a lead.

Pets must **NOT** be left in an unattended vehicle. Marston Steam and Vintage Show reserve the right to forcibly enter a vehicle should we believe that an animal is in distress and the authorities will be informed.

It is your responsibility to clean up after your pets and dispose of in the bins provided.
